- Public Works Departments:

 Decorative Lights: We will be testing a basic procedure, this Spring, of wire brushing, sanding and an aluminum paint in order to see how well it will adhere.

 Catch basin repairs are delayed. We will do our best to get them completed soon with limited staff.

 We will be measuring the area downtown to see if painting parking spaces will allow for more parking spaces.

 2020/2021 winter salt usage currently at 80-90 tons.

 Currently working on all touch-less equipment installs such as, sinks, toilets, and water fountains.

- Water Department:

 Sanitary Survey: Updating the number of private well locations to complete our backflow
 - Adam's Street Tower demo is now estimated to be perform in the Spring. Additional details for this decision can be explained at the council meeting.

- 2021 Road Reconstruction/Resurfacing Projects:

 Submitting for CDBG Funds for the reconstruction of Fenwick Phase 1. Seeking Grant in the amount of \$372,000 with the City matching share of \$59,000

 Working with Clark County Engineer on a preliminary assessment of a street(s) to be resurfaced. 2021 funding may be lower than last year due to cost share and engineering for the Fenwick project, if approved, and gas tax revenues that fell short in 2020.

Madison St. School Demo:

• Environmental review to start soon. Demo to take place late Spring into early Summer. City crews will clean up all spoil piles behind school to meet federal requirements for when the School is demolished. Total cost \$226,202 with the City share to be \$52,302.

Comments/questions: Nowakowski noted Jeff Eggleston is looking to expand the business this summer so the log home would need to be moved this spring. Bridge noted admins open to idea, would like to see it close to Washington St. Suggests at the next work session discussing. Kitko and Hutchinson note ways the city can move the home, precautions to take and it will be costly. Bridge suggests meeting with Eggleston. Rodewald noted he is not on board with spending 6 figures on a log cabin. Harris notes once a price is down she could advise if it is a smart move. VM Cook motions to invite Jeff Eggleston to the next work session to share information he has moving the home with a 2nd by Nowakowski. Re: Mayor's Court

Date: November 13, 2020

After looking into mayor's courts, I believe City Council should consider the following information:

• Possibility of conducting a mayor's court without a police force. There are four mayor's courts, out of two hundred ninety-two mayor's courts in Ohio, operated by villages or municipalities without their own police departments. Like New Carlisle, those four local governments contract with sheriff's departments or the police departments of other local governments for police protection. Those four courts are located in the following villages: Lucas (contract with Richland County Sheriff), Malta (contract with Morgan County Sheriff), Marble Cliff (contract with Grandview Heights Police), and South Lebanon (contract with Warren County Sheriff).

Section 1905.08 states, in part, that "[t]he chief of police of the city * * * or a police officer of the city * * * designated by him * * * shall attend the sittings of the mayor's court to execute the orders and process of the court, and to preserve order in it * * *." For the City to meet this obligation under the Revised Code, it appears that someone from the sheriff's department would need to be designated as the chief of police for mayor's court purposes. Because of that, this would need to be addressed in the next contract with the Clark County Sheriff and the Clark County Board of Commissioners.

It should be noted that not all mayor's courts precisely follow the Revised Code. For instance, no law enforcement officer is involved with the mayor's court for the Village of Lucas.

Because mayor's courts in local governments without police departments are relatively rare and because of the complication of the City needing a designated chief of police from the Clark County Sheriff's Department, I have reached out to head counsel for the Ohio Municipal League for guidance. I will provide further information after I receive his opinion.

• <u>Types of mayor's courts</u>. Mayor's courts operate differently across the state. There are three main types of mayor's courts. Generally, there are mayor's courts that hear: 1)

traffic offenses, including OVI, and some criminal misdemeanors; 2) traffic including OVI; and 3) traffic without OVI. Even within those three main types, court operations vary. For instance, the Village of Lucas, which is a traffic without OVI type, does not hold trials and transfers any disputed cases to the Richland County Municipal Court.

• <u>Magistrate and educational requirements</u>. The mayor may appoint a person as mayor's court magistrate to hear cases within the jurisdiction of the mayor's court, but the mayor retains the authority to hear any such cases.

Any mayor or magistrate who intends on hearing cases must receive six hours of initial training for OVI cases, six hours of initial training for offenses unrelated to OVI, or both if the court intends on prosecuting OVI and offenses unrelated to OVI.

After the first year, the mayor and/or magistrate will need to receive three hours of continuing education for OVI cases, three hours for non-OVI cases, or both if the court hears OVI and non-OVI cases.

Initial and continuing education is available through the Ohio Municipal League. The next course offerings will probably be in January 2021.


• Ohio Supreme Court registration and reporting. Each mayor of a local government that operates a mayor's court must submit a mayor's court registration on or before January 15th of each year or not less than fifteen days prior to conducting mayor's court, whichever is later.

The mayor must submit a mayor's court report no later that the 15th day of January, April, July, and October of each year.

The purpose of registering and reporting is to: (1) identify all mayor's courts being operated, and provide the mayor's/magistrate's names and dates of education requirement completion; (2) provide statistical data for the number of cases; and (3) measure compliance with case processing and time guidelines.





The City of Athens community swimming pool had reached its useful lifespan and repairs were growing exponentially with each season's use. This project replaces the existing swimming pool bath house, pump house and swimming pool and is the next renovation project to update public pool facilities throughout the city. The scope includes the replacement of the dated 1920s pool with two zero entry zones: a tot pool for younger children which includes spray fountains and a barrier from deeper water, and a second zone for older children which integrates an interactive water feature play structure and slide tower with water depths down to 3 ½ feet. Additional play features include a 6-lane lap pool and a dive pool. Site improvements include the preservation of mature trees, new pathways, shade furnishings, two open-air shelters, and a perimeter gate for safety and security. MKSK provided full site design services from schematic design through construction observation.

The Dodge Park Swimming Pool is located in Dodge Park within the Whittier Peninsula neighborhood just west of downtown Columbus. The new pool and bath house facility replaces a 50+ year-old facility that had served its useful life. The program that drove the design of the pool features and site amenities was obtained and validated through several community meetings Features include a six lane 25-yard competition pool connected to a family open swim area with underwater benches and deck water sprays that arch into the pool area creating a festive water environment. In addition, a zero beach pool with an interactive water feature play structure serves as the central play point for young children. The primary visual feature of the new pool is a colorful double slide tower that drops swimmers over two stories splashing into a separate open pool below. The City and the residents also retained diving through creating a separate diving pool with two one meter boards, a popular feature for teenagers. Attendance has exceeded all expectations at the new facility.

Site amenities includes a six-lane competition pool which seamlessly transitions to the large openswim area. A zero-entry feature at the southeast end of the pool provides play space for toddlers, as well as a comfortable ADA accessible entry for disabled patrons. A separate diving well is equipped with two one-meter diving boards for endless cannonball fun. However, it is the double slide tower which shines as the focal point for the site. One slide is an open-flume ride giving the user a view of the entire park. The adjacent slide is a closed-flume experience as it unexpectedly propels the user into the water at the end of the ride. MKSK provided full services from site planning through design and implementation. The Lincoln Pool held its grand opening in June 2015. The facility is anticipated to draw large crowds from the neighboring areas and be a successful cultural investment for the City.

The community center nearly doubled in size and offers a new gymnasium, kitchen and learning spaces. The new pool site shares locker room facilities with the center addition. This arrangement provided a cost savings to the project allowing for supplementary pool amenities. Amenities include a six-lane, 25-yard competition length pool. This connects to the large free-swim area where guests can play or partake in the available swim lessons. There is a tot pool for the littlest swimmers and a zero-entry feature for toddlers and waders alike. The zero-entry zone also accommodates ADA requirements for a comfortable entry for all users. Additionally, the site will have a separate diving well and a towering double water slide for the adventurous swimmer.
