There's a dog running loose on...

We often see posts on Facebook and receive calls about dogs running at large. It seems that everyday a new post is made about a dog either running the neighborhood or a neighbor has 4-5 dogs that keeps getting out of the yard, barks all day and night, and a dog attacked another animal, person, even a child. New Carlisle is not the only city that



dogs, cats, geese or other fowl or animals shall permit them to run at large upon public ways or upon unenclosed land or upon the premises of another without permission.

(c) No owner, keeper or harborer of any dog or cat shall fail at any time to keep it either physically confined or restrained upon the premises of the owner, keeper or harborer by a leash, tether, or secure enclosure to prevent escape.

(e) Whoever violates division(a) of this section is guilty of a misdemeanor of the fourth degree.

has this issue, it is happening everywhere.

Unfortunately, city ordinances only allow so much enforcement from law enforcement and code enforcement leaving the only other resource is an underfunded, understaffed animal control. How will we as a community of neighbors helping neighbors reduce the amount of dogs and the frequency of dogs running at large?

Complaints that come into the city or post made on social media provide great details about the dogs running at large, meaning, who owns them, where they come from, where they are going, and how often the dog is running at large. Code enforcement and law enforcement can and will enforce the following ordinances related to dogs. So please read them and if you have any questions please reach out to code enforcement.

618.001 DEFINITIONS

(b) "At large" means off the premises of the owner.(h) "Kennel" means any lot or premises on which four or more domesticated animals more than four months of age are housed, groomed, bred, boarded, trained or sold.

618.01 ANIMALS RUNNING AT LARGE.

(a) No person who is the owner or keeper of horses, mules, cattle, sheep, goats, swine,

Punishment shall be as provided in Section 698.02.

618.07 NOISY ANIMALS.

(a) No person shall keep or harbor any dog, cat, fowl, or other noisy animal which, by frequent and habitual barking, howling, crying, yelping, or by any other means creates unreasonably loud or disturbing noises of such a character, intensity and duration as to disturb the peace, quiet and tranquility of the City. Any person who allows any such animal habitually to remain or be lodged or fed within any dwelling, building, yard or enclosure, which he or she occupies or owns, shall be considered to be harboring such animal.

618.18 KENNELS.

(a) As defined by Section 1240.05(70) of the Codified Ordinances, a "kennel" means any lot or premises on which four or more domesticated animals, more than four months of age, are housed, groomed, bred, boarded, trained or sold.
(b) A kennel is considered a permitted use in only the General Business District and the Agricultural Districts of the City.

(c) Anyone who owns or operates a kennel in any other area of the City is guilty of violating the Zoning Code of the City.


BUSINESS SPOTLIGHT ON... MARATHON - ALL IN ONE!
