Benchmark Snapshot (Ohio peers – typical ranges)

- Single niche (resident): \$2,000–\$2,500.
- Single niche (non-resident): \$2,500-\$3,000
- Double/companion niche: \$3,500–\$3,700
- Inturnment/open-close fee: \$350–\$550 (wknd/holiday surcharge often applies)
- Inscription/faceplate engraving: \$200–\$500 (by City-approved vendor)
- Disinturnment/transfer: \$300–\$600

Notes: Many cities offer resident discounts, limit décor, and standardize engraving to keep a uniform look.

Key Policy Decisions (for Council vote)

- 1. Eligibility & Priority
 - Offer to any purchaser, with resident discount (recommended) and resident-only presale for first 60 days.
- 2. Capacity
 - Max two urns per niche (must fit size specification; human cremated remains only).
- 3. Pricing model
 - o Tiered by panel/height (premium for eye-level), or flat price.
 - o Separate fees for inurnment, inscription, disinturnment, replacement faceplate.
- 4. Aesthetics & Décor
 - o City-approved standard inscription (font/emblem rules).
 - No external décor (tape, plaques, vases) on the structure; seasonal flowers allowed at ground beds per cemetery rules.
- 5. Scheduling & Staffing
 - o Inurnments Mon–Fri during business hours by appointment; surcharge for weekends/holidays.
- 6. Transfers & Refunds
 - o Allow inter-family transfers (admin fee).
 - o Buy-back at original price minus 15% admin if unused.

Proposed Fee Schedule (Draft)

Niche Purchase (per niche)

- Resident: \$1,800 (Tier A premium panels: \$2,000)
- Non-resident: \$2,300 (Tier A premium panels: \$2,500)
- Companion upgrade (two urns in one niche): Included if within size limits

Service Fees

- Inturnment (open/close): \$450 current is 350
 - Weekend/Holiday surcharge: +\$200 current 100 more holiday and Sunday 200 more
- Inscription (standard 2 names + dates, one emblem): \$375
 - Additional emblem or line: \$75
- Disinturnment/Transfer (admin + labor): \$500
- Replacement faceplate (damage/re-engrave): Cost + \$150 admin

Administrative

• Buy-back (unused niche only): Original price – 15% admin?

Common Rules & Practices

- Capacity: Max two urns per niche is the norm. <u>City of Willoughby, OhioAmerican Legal PublishingCity of Mentor, Ohio</u>
- Container/contents: Human cremated remains only; urns must fit stated niche capacity. American Legal Publishing+1
- **Faceplate/engraving:** City-specified engraver; no drilling/attachments; military emblems sometimes allowed via city contractor. marysvilleohio.org
- **Decorations:** Frequently **not permitted** on or around columbarium; some cities standardize bud vases or forbid all décor. American Legal PublishingTroy, Ohio
- Opening/closing & timing: Separate inurnment (open/close) fees or included in purchase; higher charges for weekends/after hours. Hudson Official WebsiteTroy, Ohio
- **Resident preference/discounts:** Many offer **resident discounts** or restrict new sales to residents/past residents. <u>Beavercreek, OHcopley.oh.us</u>
- State law backdrop: Opening/closing of a niche requires cemetery permission per Ohio R.C. 1721. Ohio Laws+1

5. Administration

o Written permit required for inurnment per R.C. 1721; staff handles scheduling
